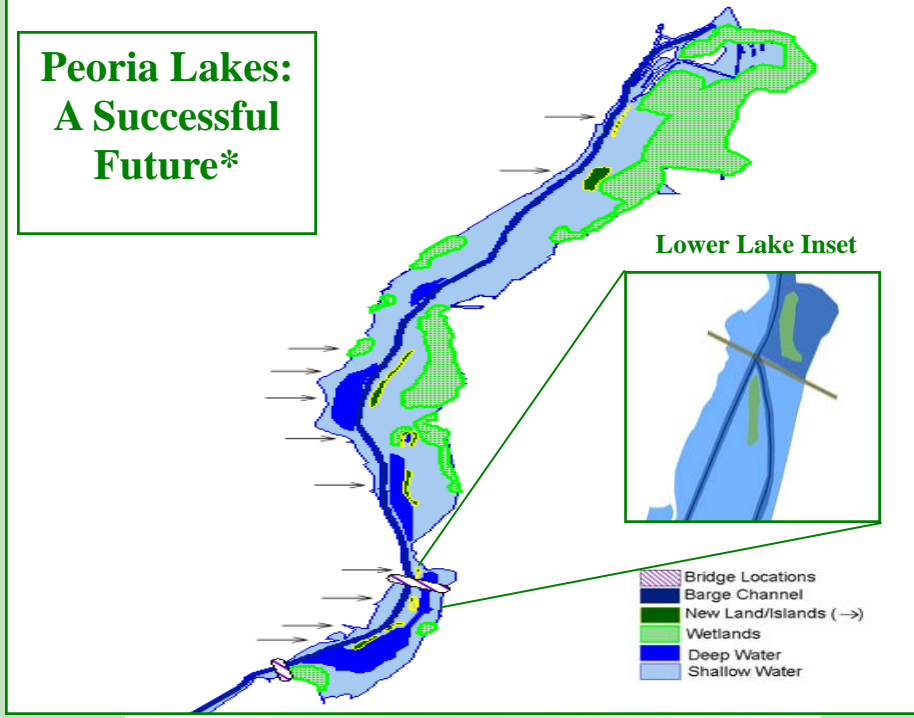


Existing federal, state, and non-government programs provide opportunities to restore and maintain healthy river habitat.

These programs include:

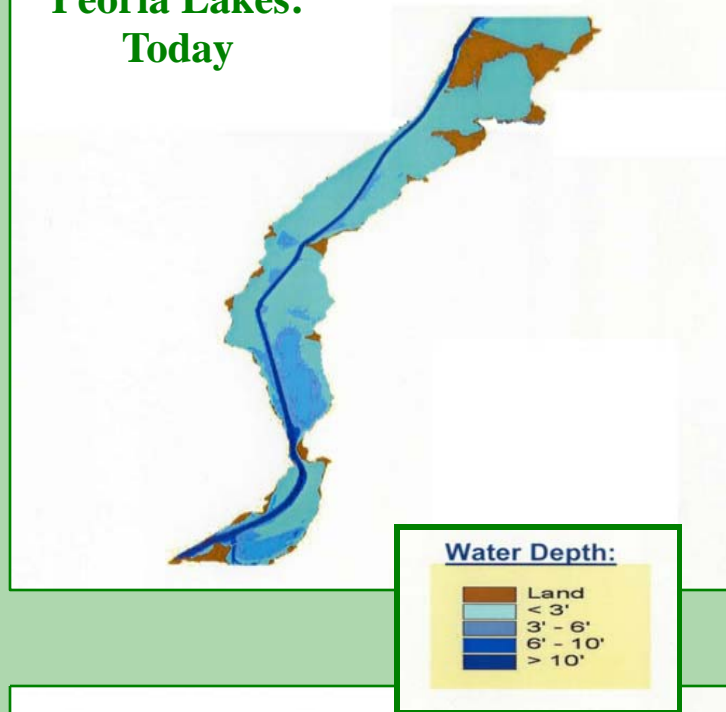
- ◆ Illinois Rivers 2020

Peoria Lakes Alternatives (Acres)*

No Restoration	500	0	0	0	13,500	14,000
Partial Restoration	500	350	4,950	1,700	6,500	14,000
Full Restoration	500	750	9,750	2,500	500	14,000

Solutions

- ◆ Reduce sediment from entering the Peoria Lakes
- ◆ Manage siltation to protect critical areas
- ◆ Selectively remove accumulated sediment from the Peoria Lakes to increase:
 - ◆ Depth
 - ◆ Habitat diversity
 - ◆ Recreational opportunities
- ◆ Improve control of river levels to reduce unnatural water level fluctuations
- ◆ Create a secondary channel with selective island placement

Next Steps

- ◆ Identify sites that maximize benefits of sediment removal
- ◆ Determine sites and specifications for new islands
- ◆ Locate upland placement areas for dredge material
- ◆ Develop upland restoration & sediment control measures

- ◆ Residential & commercial construction projects
- ◆ Urban storm water run-off
- ◆ Streambank erosion
- ◆ Agricultural land
- ◆ Steeply-sloped forested bluff areas
- ◆ 50% of the sediment in the Peoria Lakes originates from our *own* Tri-County area
